- 1. Last year we wrote and passed the Staback Hunter Self Defense Act.
- 2. Last year **we blocked passage of gun rationing and gun bans** and dozens of other types of ill-conceived legislation.
- 3. This year, with your help, we can pass the Cappelli Castle Doctrine legislation.
- 4. This year, with your help we can force the **Pennsylvania State Parks** to obey the law and stop fining permit holders for lawfully doing what they are licensed to do.
- 5. You can help us protect you from identity thieves by ending the ill-advised practice of forcing you to risk identity theft by giving people your Social Security number for recreational licenses.
- 6. Gun registration is illegal in Pennsylvania but the Pennsylvania State Police do it anyway draining many millions of dollars from genuine law enforcement programs that actually fight crime. Last year we challenged them to produce a COST-BENEFIT ANALYSIS and they cannot do so. Lets work together to stop the squandering of taxpayer money on an illegal program.
- 7. **Firearms registration is confiscation in due course.** It happened in Nazi Germany, Soviet Russia, Communist Cambodia, Canada, Australia, New Jersey, New York City and California. Philadelphia politicians and other anti-gun state legislators want to do the same in Pennsylvania. We have laws that prohibit a firearms registry, but the State Police Firearms Unit ignored the law. When taken to court, they argued that the people have no standing to make them obey the law. Three notorious justices of the Pennsylvania Supreme Court (**Cappy, Eakin and Castille**) decided that it is OK to disregard the plain language of the law.
- 8. In Stalinist Russia you could lose your rights and property without even being convicted of a crime. In PA today you can lose your rights and property without even being convicted of a crime. They call it a PFA.
- 9. You can have a voice and make a difference if you work with us!

The Grassroots organizations, ACSL, PSA, and PFSC, have cooperated in drafting legislation to correct the above injustices and we need YOUR help with lawmakers to pass corrective legislation into law.
