## NWTF Technical Committee Representatives' Report - PA Chapter NWTF Board of Directors Meeting, Pleasant Gap, PA June 7, 2008

#### **Harvest Management**

Harvest report cards received the first half of the spring turkey season are 56% above the previous 3-year average for the same time period. Reasons for this harvest increase include good weather for hunting and hearing turkeys, a slightly earlier start to the season due to the annual calendar, and a healthy turkey population in most areas; all of which differ from the previous 3 years. We continue to receive report cards until the 4<sup>th</sup> Wednesday after the close of the season (June 18<sup>th</sup> this year), at which time we make our final count.

Final count of special turkey licenses sold for 2008 is 8,795, an increase of 16% from 2007, and a 9% increase from 2006, the first year they were offered. Of these, we have received reports of 688 harvests (as of 5/20/08), a 97% increase from the same time last year. Most of this increase, however, likely is due to hunters now becoming familiar with the reporting procedure of this license rather than a substantial increase in harvest.

Preliminary calculated fall 2007 turkey harvest was 21,900 (Table 1). This was 2% higher than the preliminary fall 2006 turkey harvest (21,500), but 9% below the previous 3-year preliminary average (24,180). Final fall 2007 harvest figures will be available in July after completion of the annual Game-Take Survey, which will provide hunter participation and harvest estimates. Fall turkey harvests fluctuate annually according to fall season length, summer reproduction, hunter participation, fall mast crop and weather. We lengthened the season in 1

WMU in 2007 (4D) but shortened the season in 2 WMUs (2A & 2F). Additionally we shortened the season in 3 WMUs in 2005 (1A, 5C & 5D) and 5 WMUs in 2004 (2C, 2E, 4A, 4B & 4D). Numbers of fall turkey hunters and days fall turkey hunting have been decreasing since the mid 1990s. Fall turkey harvest in neighboring New York also was higher than last year due to good summer reproduction.

The PGC turkey biologist responded to over one dozen inquiries from the public, newspapers and magazines regarding an array of turkey harvest, management and turkey hunting questions and provided telephone interviews to several outdoor and newspaper writers.

#### Wild Turkey Management Plan

The annual review of the wild turkey management plan strategies is underway in preparation for the annual PGC/PANWTF Cooperative meeting (June 9, 2008). Each PGC Bureau is reviewing management plan strategies they are responsible for to show outputs and outcomes, if the timeframe for accomplishments is being maintained, and identifying potential problems with implementation.. The management plan implementation schedule (Appendix 1 in the plan document) is attached with an initial review of strategies. A complete review will be provided at the PGC/PANWTF meeting.

The regional wild turkey population model requires an annual recruitment variable, ratio of poults per hen, which we do not directly measure. We revised the statewide turkey summer sighting survey and Michaux summer sighting survey to calculate this directly. Previously we calculated an index of production, but not a direct measure. The statewide survey was simply used to give an index of the entire summer turkey population to track overall population changes from year to year.

The 2008 Pennsylvania Turkey Hunter Survey is being reviewed internally and, in late July, will be mailed to approximately 9,000-10,000 turkey hunters to determine their knowledge and attitudes to help the PGC direct future wild turkey management efforts.

#### Wild Turkey Spring Harvest Rates and Annual Survival Rates Study

Turkey trapping and leg banding concluded at the end of March, with 932 gobblers banded across the 3 states (NY-350, PA-332, OH-250). PA regional banding totals were: NW: 79, SW: 51, NC: 54, SC: 55, NE: 39, SE: 54, which included 152 adult gobblers and 180 juvenile males. There is one more winter of leg banding. The Cooperative Fish and Wildlife Research Unit at Penn State maintains the toll-free number for reporting leg band returns. We thank the National Wild Turkey Federation for their total financial support of \$203,893, and the Pennsylvania Chapter NWTF for their financial support of \$33,500 to date as well as volunteer assistance with turkey trapping.

Reports of harvested gobblers are coming into the toll-free phone number at the Pennsylvania Cooperative Fish and Wildlife Research Unit. As of 20 May 2008, 121 leg-banded gobblers have been reported harvested in Pennsylvania, including 4 from the youth season and one harvested with a bow. Additionally, 5 have been found dead, or legbands found and reported. This compares to 100 leg-banded gobblers reported harvested by the same time last year. One harvest is an Ohio turkey that was harvested in Beaver County, and one was a New York banded turkey harvested in Erie County. Additionally, one was banded in Greene Co. in 2007 and harvested in West Virginia, about 500-600 yds. from Mt. Morris, Pennsylvania.. Fifty-eight of the 121 harvested were reward band birds (63 were nonreward). See Table 2 for comparison of state results to date.

Additionally, possible methodologies of the future turkey hen harvest rate study were investigated with the assistance of Dr. Duane Diefenbach (PSU).

As part of the NE Wild Turkey Technical Committee the turkey biologist reviewed and provided comments on 18 NWTF Grant-in-aid research proposals for wild turkey research. Our tri-state gobbler study is funded through this as well.

## Wild Turkey Trap and Transfer

Personnel from the Southwest Region transferred 44 wild turkeys (4 juvenile males, 4 adult males, 36 females) from Pittsburgh area urban and suburban nuisance flocks to South Dakota in exchange for wild ring-neck pheasants as part of the pheasant restoration program in the Southwest Region. Additionally, 23 nuisance turkeys were leg-banded and released to SGL 432 (6 adult females), SGL 297 (8 adult males, 7 adult females), and Allegheny Land Trust Property (2 adult males), a Safety Zone property as part of our 'Nuisance wild turkey transfer pilot program in Southwestern Pennsylvania, 2007-2010' to monitor (via leg-banding) whether birds return to their nuisance location and/or, if relocated turkeys become nuisances in the relocated area. Leg bands are stamped with the Southwest Region telephone number, and contain a unique alpha-numeric number.

## **Hunter- Related Shooting Incidents**

Preliminary results show eight (8) nonfatal spring 2008 gobbler season hunter related shooting incidents, compared to 5 in 2007 and 8.6 for the previous 10-year average (Table 3, containing reports of 5 of the 8 incidents). Incidents occurred in these counties: Allegheny, Cambria (2), Clinton, Cumberland, Luzerne, Lycoming and Northumberland.

#### **Michaux State Forest Summer Sighting Surveys**

Thanks to a well-established cooperative effort among the PGC, DCNR Bureau of Forestry (BOF), and volunteers from the National Wild Turkey Federation, the eleventh year of weekly Summer Sighting Surveys on the Michaux State Forest will be conducted to provide an additional index to turkey population trends besides our harvest and hunting success trend data for WMU 5A. This is the area of the turkey radio-telemetry study where we investigated the causes of the suppressed wild turkey population, and closed the fall season in 2003 to aid in population recovery. Additionally, since 2002, BOF staff record on a daily basis, all turkeys they see and miles driven, to get an index of turkeys seen per mile driven and productivity (poults/hen), as additional indices of the turkey population. Also, each summer since 2003 volunteers from local chapters have been conducting surveys of turkey usage of wildlife openings on the Michaux State Forest to determine the best mowing schedule for turkeys. This is the last summer of surveys and their assistance has been appreciated.

#### Wild Turkey Management Plan Assessment Fiscal Year 2007 - 2008

**Population Objective**: Sustain or enhance healthy wild turkey populations in each Wildlife Management Unit (WMU) at or below social carrying capacity.

**Strategy 1.1.** Provide spring and fall hunting opportunities while maintaining or enhancing populations at or below social carrying capacity.

Outcomes: On-going.

**Outputs:** Analyzed trends in spring harvest densities and WCO summer sighting surveys by WMU for seasons and bag limits recommendations, as well as fall harvest densities, spring and fall hunter success, and additional harvest from the special spring license.

**Strategy 1.2.** Use fall season lengths as primary means for managing populations.

Outcomes: On-going.

**Outputs:** As per recommendations by PGC staff, based on biological and population data analyses, the Board of Commissioners approved to maintain existing fall season lengths in all WMUs for the fall 2008 turkey season, to comply with the recommendations in the management plan for establishing fall season lengths of maintaining any changes for at least three years to assess impacts of the change.

**Strategy 1.3.** Assess turkey population status and trends.

Outcomes: On-going.

**Outputs:** Analyzed trends in spring harvest densities and WCO summer sighting surveys by WMU for seasons and bag limits recommendations.

**Strategy 1.4.** Collect age and sex information of harvested turkeys for spring and fall seasons. **Outcomes:** Data being collected on Game-Take Survey, and will be collected via the

reporting portion of the Automated Licensing System, which may be implemented by July 2010.

Outputs: Postponed until POS is in place.

**Strategy 1.5.** – Implement spring gobbler hunter survey

Outcomes: Behind schedule.

Outputs: Postponed until POS is implemented.

**Strategy 1.6.** Evaluate the new mid-Atlantic turkey population model for application in Pennsylvania, and implement in 2008.

Outcomes: In progress and on schedule.

**Outputs:** Met with B.Eriksen, VT's turkey biologist & model author, J.McQhee, to review model implementation for PA & VT. Model requires an annual recruitment variable, ratio of poults per hen, which we do not directly measure. Statewide turkey summer sighting survey and Michaux summer sighting survey were revised to calculate this directly. Previously we calculated an index of production, but not a direct measure. The statewide survey was simply used to give an index of the entire summer turkey population to track overall population changes from year to year.

**Strategy 1.7.** If necessary, develop and implement research to collect data to validate the new population model.

**Outcomes:** In progress and on schedule.

**Outputs:** Statewide turkey summer sighting survey and Michaux summer sighting survey were revised to directly measure annual recruitment, ratio of poults per hen. Previously

we calculated an index of production, but not a direct measure. The statewide survey was simply used to give an index of the entire summer turkey population to track overall population changes from year to year.

**Strategy 1.8.** Conduct the 4-year multi-state gobbler harvest and annual survival rate study.

Outcomes: On schedule. Third year nearing completion.

**Outputs:** 3-year results: 2,632 male turkeys banded, close to quota of 2,700 (NY: 1,029; PA: 912; OH: 691).

PRELIMINARY results of first 2 years: harvest rates: Adult gobblers 36% (31-40%), juveniles 19% (14-23%). Reporting rates: Adults 75-100%, juveniles 74-78%. Rewards distributed to date: \$42,500 total, \$17,100 in PA. At completion of study, results will be analyzed by state, WMU, landscape characteristics and land ownership. Results also will be used in the new population model.

NWTF 4-year funding = \$203,893, PANWTF funding to date = \$33,500.

**Strategy 1.9.** Conduct a hen harvest and annual survival rate study.

Outcomes: On schedule.

**Outputs:** Met with Dr. Duane Diefenbach, B.Eriksen, and others to develop methodology of study and determine what states may be involved. Project plan will be drafted by July 2008.

**Strategy 1.10.** Determine if the sample units of WMUs provide reliable trends for harvest and summer sighting data.

Outcomes: No progress.

**Outputs:** To be completed in 2008. Data needed for hen harvest rate study.

**Strategy 1.11.** Determine if the two-bird spring bag limit has any effect on the turkey age structure and, if needed, recommend regulation changes.

**Outcomes:** On schedule to be done in 2008.

**Outputs:** To begin this summer once Game-Take survey data are available.

**Strategy 1.12.** Develop standard solutions to nuisance turkey complaints.

**Outcomes:** Behind schedule. Standard Operating Procedure (SOP) was drafted and reviewed in 2007. Initiated 3-year pilot nuisance wild turkey transfer program in southwestern PA during 2008.

**Outputs:** SOP to be completed in 2008. 23 nuisance turkeys were leg-banded and released to three different SGLs to monitor (via leg-banding) whether birds return to their nuisance location and/or, if relocated turkeys become nuisances in the relocated area. Leg bands are stamped with the Southwest Region telephone number, and contain a unique alpha-numeric number. Two legband returns were reported from successful (and pleased) hunters during the spring 2008 season.

**Strategy 1.13.** Quantify turkey complaints by season, type and location.

Outcomes: No progress. Complaints have not been significant.

Strategy 1.14. Train personnel in identifying agricultural damage caused by turkeys.

**Outcomes:** Behind schedule. Cooperative effort with NWTF. NWTF Regional Biologist will provide training to Wildlife Conservation Officers at PGC Regional meetings. Damage has not been significant so training has not been a priority.

Outputs: Training might be scheduled for 2008.

**Habitat Objective:** <u>Improve quality of existing, and minimize loss of, wild turkey habitat</u> throughout the state.

**Strategy 2.1.** Determine turkey habitat management priorities for State Game Lands while considering habitat on adjacent properties.

**Outcomes:** Updated habitat management trainings have been and will continue to be provided to regional personnel (land managers, foresters and biologists). Effective management of openings for turkeys has been emphasized. Information garnered during trainings and field exercises is being incorporated into comprehensive game lands plans. The combination of training and planning is resulting in focused management and improved turkey habitat on state game lands.

## **Outputs:**

Indoor trainings provided: 6 Hours of field exercises: 80 Personnel trained: 116

Game lands habitat plan drafts: 16

**Strategy 2.2.** Beginning 2008, quantify habitat management practices being conducted on State Game Lands to benefit wild turkeys.

**Outcomes:** Developing a tracking system to track habitat improvements specific to wild turkey on SGLs through the SGL planning and implementation program.

## **Outputs:**

Beginning 2008:

Number acres planned and Number acres implemented

**Strategy 2.3.** Evaluate efficacy of habitat management practices on State Game Lands, and recommend adjustments.

**Outcomes:** Habitat is being improved through approaches that incorporate current knowledge on best management practices for turkeys. The earliest improvements were initiated in spring 2006, and vegetative response is now becoming apparent. Progress continues to be monitored and techniques adjusted through game lands habitat planning and implementation.

Evaluating habitat management practices for turkeys is part of an adaptive resource management approach. Based on the habitat monitoring aspect of SGL planning, BHM is revising the "Habitat Management Manual". This manual will reflect current best management practices for turkey habitat and will evolve as monitoring continues and new information is available.

## **Outputs:**

Revised outline and supporting materials for the Habitat Management Manual.

**Strategy 2.4.** Develop at least two demonstration areas per Region to promote habitat management to other public agencies and private landowners.

**Outcomes:** To streamline this process, a single, centrally located demonstration area is being established on SGL 252 (Union and Lycoming Counties)

**Strategy 2.5.** Scheduled to begin 2009, once demonstration area is established.

**Strategy 2.6.** Develop and/or continue partnerships for habitat funding. **Outcomes:** Game Lands Planning Section played an active role in the NWTF Superfund proposal process. Proposals were connected to specific habitat practices and SGL plans, ensuring that NWTF funds are used to their fullest potential.

## **Output:**

Funds secured for 2008: \$68,785 Game lands projects funded: 40

**Strategy 2.7.** Provide technical information and assistance regarding turkey habitat management to other public land managers and private landowners

**Outcomes:** Presented technical information on turkey habitat management to woodland landowner associations, hunting leases, conservation groups, and private landowners.

## **Outputs:**

Presentations conducted: 7 Individuals reached: 200

#### **Strategy 2.8.** Promote use of prescribed fire.

**Outcomes:** Field personnel were trained in prescribed fire planning for Farm Bill Programs on private lands. Regional personnel conducted prescribed burns on state game lands to improve conditions in both forested and herbaceous areas. From a policy standpoint, the Prescribed Fire Council was created with representatives from PGC (BWHM) taking an active role. From a policy standpoint, PGC (BWHM) is taking an active role in the Prescribed Fire Council. Also participated in and developed a poster entitled, "*Use of Prescribed Fire in PGC Habitat Management*" at the Prescribed Fire Conference in February 2008.

## **Outputs:**

Personnel trained: 25 Policy meetings attended: 6

Acres burned: Prescribed fire season ended May 2008, final acreage yet to be compiled.

Approximately 200 acres burned on game lands.

**Information and Education Objective:** Assess and improve the publics' knowledge, awareness and understanding of the wild turkey resource and its management.

**Strategy 3.1**. Beginning in 2007, and at 5-year intervals, conduct surveys to determine knowledge, attitudes, characteristics and levels of satisfaction of hunters and other stakeholders toward wild turkey populations and management issues.

**Outcomes:** Behind schedule due to delay of hiring biometrician in BWM and delay in implementing Point of Sale.

**Outputs:** Draft survey developed by BWM and currently being reviewed. Survey to be mailed in July 2008 to 9,000 – 10,000 hunters. Final report expected December 2008.

**Strategy 3.2.** Annually report research and management findings and conclusions to the public through all forms of media.

Outcomes: Ongoing.

**Outputs:** At least 6 news releases published, information placed in digest and hunting annual, turkey page on website updated several times, continuing to provide the latest information on turkey research/mgmt, on average 1 program provided per month by the turkey biologist to sportsmen clubs, NGOs and the general public. NWTF Technical representative attends quarterly PANWTF Board meetings and bi-annual Technical Committee meetings. Turkey biologist responded to over 40 inquiries via emails, phone calls and letters from the public. NWTF Regional Biologist provides information to the public and responds to even more requests for information via articles, presentations, emails, phone calls and letters. TMA 7B study research paper was published in NWT Symposium proceedings. Preliminary study results of the gobbler survival rate study were presented to NWTF national and northeast technical committees, NYDEC, PGC, PANWTF, and several sportsmen and conservation groups.

**Strategy 3.3**. Annually provide educational information through all forms of media and speaking engagements on various aspects of wild turkey biology, habitat management, and harvest management (including resolving nuisance/conflict situations, harvest reporting and its misconceptions and the importance of properly timing the opening of our spring season).

Outcomes: Ongoing.

**Outputs:** Six news releases in 2007, Turkey FAQs published as spring 2008 Game News article. Turkey biologist provided, on average, 1 program per month to the public on all aspects of wild turkey management/biology, and responded to over 40 inquiries via emails, phone calls and letters from the public. Local WCOs provide programs on turkeys. NWTF Regional Biologist provides information and responds to even more requests for information to the public via articles, presentations, emails, phone calls and letters.

**Strategy 3.4.** Beginning in 2007, develop and publish fact sheets or "frequently asked questions" information sheets on various aspects of wild turkey management addressing common questions and misunderstandings; put on PGC website, in the *Hunting and Trapping Digest* and *Game News* as appropriate.

Outcomes: On-going.

Outputs: Turkey FAQs published as spring 2008 Game News article. .

**Strategy 3.5**. By 2008, disseminate information through all forms of media to farmers and other landowners about turkey behavior and how to identify and handle crop damage and nuisances in urban-suburban areas.

**Outcomes:** Limited progress. Cooperative with NWTF. NWTF Regional Biologist will develop and distribute via PGC.

**Outputs:** NWTF Regional Biologist and PGC NW RWMS handled a suspected turkey crop damage incident in NW PA of silage storage bags. They proved, via field inspection and trail cameras, crop damage was caused by a family of coyotes feeding on rodents in

the silage bags, and the turkeys were simply opportunistically feeding. Information to be published in PA Turkey Talk.

**Hunting Heritage/Hunter Safety Objective:** <u>Promote and improve the knowledge, safety and participation of wild turkey hunters.</u>

**Strategy 4.1.** By 2008 evaluate the option of expanding hunter education programs to include an optional and separate course in wild turkey hunting and safety.

**Outcomes:** Federal Assistance Program funding will be requested.

**Outputs:** Part of next 5-year planning for hunter education, this is part of the next planning. First to fully implement new basic program curriculum statewide before implementing advanced curriculum. Spring 2009 – scheduled to complete the transition. Other advanced programs include fur-taker and muzzleloader programs. Curriculum development is scheduled to begin in 2009, but implementation should be moved to 2010 at earliest.

**Strategy 4.2.** By 2009 determine participation rates of the various age segments of turkey hunters and recommend ways of increasing participation of those various segments.

**Outcomes:** Contingent on POS, which may be implemented by July 2009(?). **Outputs:** Scheduled to be conducted in conjunction with implementation of POS.

**Strategy 4.3.** Annually assess and explore opportunities for continued development of the turkey hunting aspect of the youth mentored hunting program in Pennsylvania.

Outcomes: On-going.

**Outputs:** Part of season/bag limits recommendations process. Cooperative effort with NWTF.

**Strategy 4.4.** By 2007 evaluate the pros and cons of expanding the youth spring gobbler season to an all-day season.

**Outcomes:** No progress..

**Outputs:** Part of season/bag limits recommendations process. Cooperative effort with NWTF. On hold until completion of tri-state gobbler study.

**Strategy 4.5.** Annually consider implementation of expanded spring hunting opportunities, including, but not limited to, multiple bird bag limits, extended hunting hours, Sunday hunting, and longer seasons.

Outcomes: On-going.

**Outputs:** Part of season/bag limits recommendations process. Cooperative effort with NWTF. Beginning with 2008 spring season, Board of Commissioners approved PANWTF's recommendation to extend length of spring season one day to include Memorial Day.

**Strategy 4.6.** Annually maintain and expand the Game Commission's public access programs to promote and protect these privately owned lands open to public hunting.

**Outcomes:** On-going. The Game Commission's public access programs were continued and the Public Access Program Cooperative Agreement was updated and distributed to Regions for implementation. New enrollment options were provided to program participants to increase retention rates and address participant concerns.

**Outputs:** As of May 2008 1,095 new agreements were added for a total of 7,676 properties under agreement in Public Access programs.

**Strategy 4.7.** Annually acquire turkey habitat in order to expand hunting opportunities.

**Outcomes:** On-going. Added acres for habitat conservation and public hunting access to the State Game Lands System. All of these acres occur within prime wild turkey range.

Outputs: As of June 1, 2008: 18 tracts involving 652 acres

**Strategy 4.8.** Once a database of turkey hunters is established develop and distribute educational and hunter safety materials directly to turkey hunters.

Outcomes: Contingent on POS.

Outputs: Possibly begin FY 2008 or 2009.

**Strategy 4.9.** By 2011 investigate relationships between spring and fall hunter density and turkey hunter safety, and compare with other states. If considered necessary, recommend regulation changes to control hunter density by WMU.

Outcomes: Contingent on POS.

**Outputs:** Scheduled for completion by 2011.

**Strategy 4.10.** Annually conduct information and education programs within the agency and with partners to help minimize and control turkey hunting related shooting incidents and to promote wild turkey hunter safety/ethics.

**Outcomes:** On-going, cooperative effort with NWTF.

**Outputs:** NWTF and PGC published several news releases, info on the websites, digest, NWTF sponsored billboards, PSAs. Advanced hunter education will address this as well. PANWTF developed and published a color, tri-fold hunting safety brochure, on PANWTF web-site, in PGC 2008 Digest, mailed to hunters with the 2008 special spring turkey license, and distributed to the public and conservation organizations.

**Strategy 4.11.** Annually monitor hunter compliance with fluorescent orange turkey hunting regulations. See BWP Strategy 5.1.

Outcomes: On-going.

Outputs: Calendar Year 2007 Fall; 29 violations prosecuted. Spring: 181 violation.

**Strategy 4.12.** By 2007 review orange requirements, evaluate the pros and cons of regulatory alternatives and, if appropriate, recommend changes to the spring season fluorescent orange turkey hunting regulations.

Outcomes: Completed.

**Outputs:** Spring season fluorescent orange regulations discontinued as of spring 2008 season, as per approval by PGC Board of Commissioners..

**Strategy 4.13.** Annually assure that complete information on turkey hunting related shooting incidents are included in all International Hunting Education Association reports. On-going.

Outcomes: On-going.

**Outputs:** Oversight provided by PGC within the agency to ensure reports are complete.

Wild Turkey Protection Objective: <u>Improve hunter compliance with laws and regulations</u> regarding wild turkey management.

**Strategy 5.1.** Assess hunter compliance with laws and regulations.

Outcomes: On-going.

Calendar year data is provided to capture a spring and fall season. Fiscal year data would provide little information regarding the recently closed spring turkey season.

The addition of a species code to the PGC prosecution data base (effective 02/2008) will result in additional data next year to include additional violations specific to wild turkeys. Examples include; number of unlawfully taken turkeys, safety zone violations related to turkey hunting, tagging violations, baiting violations, closed season violations, etc.

#### **Strategy 5.2.** Utilizing partnerships to assist with purchasing equipment.

**Outcomes:** PA Game Commission Southcentral Region will propose partnership with local NWTF chapters in WMU 5A to purchase decoys for enforcing the fall turkey season closure in WMU 5A.

To date, there has been no significant movement on this increased penalty package by the General Assembly.

## **Strategy 5.3.** Seek legislation to increase penalties for serious violations.

**Outcomes:** On-going. The existing penalty structure for violations of the Game and Wildlife Code can only be altered by legislative action.

#### **Outputs:**

In January 2007, the Bureau of Wildlife Protection submitted a comprehensive increased penalty package to the legislature for review and consideration. This recommended package calls for a general increase in penalties across the sliding fine structure. In addition, the package calls for significant increased penalties for "poaching" violations primarily involving big game animals, including wild turkey.

The submitted penalty package resulted in House Bill 2205, sponsored by State Representative Edward Staback, the Chairman of the House Game and Fisheries Committee and would substantially increase the penalties for these serious violations.

Currently, the penalty for killing a wild turkey in closed season or in excess of the bag limit is classified as a summary offense of the fourth degree with a penalty of \$100 - \$300. Were HB2205 in its present form to become law, the penalties for killing a wild turkey in closed season or in excess of the bag limit would be graded as follows:

Closed season or over the limit – 1 or 2 birds

Misdemeanor 3 \$1500-\$3000 0-6 months 5 years revocation

Closed season or over the limit – 3 or 4 birds

Misdemeanor 1 \$5000-\$10000 0-24 months 10 years revocation

Closed season or over the limit -5 or more birds

Felony 3 \$10000-\$15000 0-36 months 15 years revocation

Turkeys killed in season, albeit through unlawful devices or methods, would still be classified as a summary violation of the fourth degree under a slightly modified penalty structure of \$200-\$300.

Chairman Staback would like to move this bill out of Committee in June and to the full House floor before the summer recess. When the legislative session reconvenes in September, it will be ready for action by the Senate.

The Bureau of Wildlife Protection would appreciate the National Wild Turkey Federation's **assistance with this legislation at all levels** by making contacts with the appropriate legislators and voicing your support. The passage of this bill will greatly enhance wildlife protection efforts of all big game species, including the wild turkey.

Cooperative Partnerships Objective: <u>Maintain and enhance partnerships in all aspects of wild turkey management.</u>

**Strategy 6.1.** Assist states and Canadian provinces with wild turkey restoration through trap and transfers where feasible.

**Outcomes:** Transferring wild turkeys from the Southwest Region to South Dakota in exchange for wild ring-necked pheasants.

**Outputs:** 2008 – Transferred 44 wild turkeys to South Dakota. All transfers were from over-abundant flocks in urban/suburban areas of Allegheny and Washington Counties. 2006-2008 total transfers to South Dakota:113.

**Strategy 6.2.** Continue partnership with the National Wild Turkey Federation.

**Outcomes:** NWTF Regional Biologist works cooperatively with PGC Turkey Biologist, provides assistance to PGC Regional personnel, land managers and WCOs, assists with tri-state gobbler harvest rate study, provides assistance and educational programs to landowners in cooperation with PGC. PGC Bureau of Wildlife Management Assistant Director and wild turkey biologist continue to act as technical representatives to the NWTF.

Outputs: Continued the partial funding for NWTF Regional Biologist.
