**Trip of a Lifetime Raffle-** An Estimated 191 Tickets for the Trip of a lifetime Raffle have been sold. Several more are expected to come in at the board meeting. The Drawing will be held in front of the board lunchtime Saturday. Winners will be contacted that day. Names will be turned into NWTF Headquarters. I will oversee communications with the hunt broker and winners. Thanks to those that participated.

**RD** Assignments and duties- As most know WRC's have been reassigned to RD's. All RD's will now be overseeing all aspects of fundraising and outreach events. This does not mean we will be attending all events. I had thought that our areas of responsibilities would be ironed out by today. However in light of some most recent changes I am unable to give a complete outline of Chapters and the RD that will be handling that event. We will have it hammered out in the next few weeks. When we are complete with the realignment we will e-mail the board. I would

like to report that Pennsylvania has reached 85% of repeat banquets ticketed as well as several WITO Events and Wheelin' Benefits for 2009.

George Thornton's letter:

All,

I want to update you on our progress over the last 90 days in improving NWTF operations and outline several organization and operational changes. These changes are driven by three key elements: a significant decline in our adult membership beginning in 2005, the current U.S. economic situation and a need for reinvigorating the tools we use to further our mission.

We have reviewed and evaluated the equitability of our membership dues and benefits across the membership spectrum. It is clear that membership fees are not in line with the gender of the recipients nor the ages of JAKES members. It is also apparent that we need to consider the demographics of our membership and the benefits associated with each membership category. In addition, it was determined that we have not had a dues increase in more than four years, while the cost of providing membership services has increased. Therefore, it is necessary to increase dues in several areas and adjust some member benefits, specifically JAKES.

Effective September 1, 2008, dues will be increased as outlined below. Banquets ticketed for fall 2008 will be grandfathered under the current membership dues structure. All other memberships recruited will be at the new dues rate.

- \* JAKES (ages 0-12) will increase to \$7
- \* Xtreme JAKES (ages 13-17) will increase to \$10. As an added benefit, they will receive their own password protected online magazine plus two issues of Get in the Game magazine OR two issues of Women In The Outdoors OR two issues of Wheelin? Sportsmen.
- \* Wheelin? Sportsmen and Women in the Outdoors will increase to \$30
- \* Sponsors (all categories) will increase \$10 to \$235
- \* Hunting Heritage Club will increase to \$10

\*Women in the Outdoors:\* This program will be redefined by integrating Women in the Outdoors coordinators into the regional director structure. Going forward, job duties for all regional directors will expand to include conducting Hunting Heritage Banquets, as well as Women in the Outdoors, JAKES and Wheelin? Sportsmen events and benefits. All field staff will transition into this dual role as regional directors and outreach event coordinators while still taking into account the needs of our volunteers and outreach programs. The Women in the Outdoors program is extremely important to the NWTF, therefore our efforts to sustain and grow the program will continue.

\*Donated memberships:\* We recognize that many of the chapters have

conducted separate fund raising activities and solicited donations to support their desires to donate memberships for Wheelin, Women and JAKES. In many cases, these memberships were done in an effort to bank donated memberships for future use and to increase incentive guns for their banquets or outreach events. Effective November 1, 2008, the only donated membership type that will be accepted/allowed will be JAKES and Xtreme JAKES. All other donated membership types will be counted for incentives but not be tracked in the membership numbers.

Funds from donated memberships will be handled by one of the two methods outlined below. We will create two separate ?Outreach Funds.? ?National Outreach Funds? will be used to support our national outreach efforts, and the ?State Outreach Fund? will be managed the same as the current State Super Fund.

- 1. All funds from donated JAKES and Xtreme JAKES will be split on a 50/50 ratio and deposited into the two outreach funds. Names sent in at a later date will be accompanied by a state outreach fund form. In addition, the state outreach fund only will be charged 50 percent of the new JAKES and/or Xtreme JAKES membership fees for each name provided.
- 2. Funds for adult donated memberships intentionally recorded on the banquet financial reports or reported in error will be used to support the organization?s mission. Adult donated funds will, however, be included in the calculations for incentive guns.

\*Wheelin? Sportsmen Benefits:\* The requirement for each regional director to raise \$15,000 through Wheelin? Sportsmen benefits will remain in effect. The funds will continue to be split as established in the 2003 board memo. The amount currently being deposited into the Wheelin? Sportsmen Fund will be split on a 50/50 ratio with 50 percent going into the State Outreach Fund to support state outreach efforts. The other 50 percent will go into the National Outreach Fund for national outreach activities.

Lastly, I can report that our national Board of Directors has approved our financial plan for fiscal 2009. I believe that the ?09 revenue plan is aggressive but achievable based on the plans and changes we have made, and more importantly because of the dedication and commitment I feel from our membership every day.

Management has put forth an expense plan that is responsible and conservative but recognizes rising energy and health care costs and the need to increase salaries commensurate with merit and inflation. We also have planned for a significant investment in employee training and development to ensure a strong future for the NWTF.

The benefits of the approved plan are anticipated to be:

\* A return to 2006 levels of conservation and mission development spending and a positive contribution to our end year fund balance,

which will allow us to recover from fund balance erosion in 2007 and 2008.

This is an exciting time for the NWTF as we develop new ways to achieve our mission while providing more service and better experiences for the conservation world?s greatest volunteers. Please know how much we appreciate everything you?re doing on behalf of the NWTF, the wild turkey and our hunting heritage.

#### PA Women in the Outdoors

The event season has come to a close in the state, but plans are in the works to get the events scheduled for 2009.

#### Changes in PA

As you may know, we've made some changes to the way events will be handled in the future.

With the new management at Headquarters, George Thornton wants all field staff members to be well rounded in the regions they cover. All Women's Regional Coordinators have been integrated and they are now Regional Directors.

Here in Pennsylvania, we have a staff member, Priscilla Page-Garvin who will be assisting with 2 events in the southeast corner of the state as well as working with the local chapters in Pennsylvania and Maryland.

Carl Mowry, Ray Smith and Phil Ferrare will assist with 2 events in their local areas also.

I will continue with the majority of the events, but will also be involved with numerous banquets in the region.

#### National Women in the Outdoors Event Full of Surprises for More Than 300 Women

The National Wild Turkey Federation's three-day event celebrating the NWTF's 10-year anniversary of its Women in the Outdoors outreach program proved to be full of surprises for more than 300 women in attendance.

Women from across the country as well as Canada gathered at the Wild Turkey Center in Edgefield, S.C., Sept. 25 to Sept. 28, 2008, to Learn, Laugh and Lighten Up - the theme of this year's national event.

Unexpectedly, participants received a special message from Alaskan Gov. Sarah Palin during the event's opening festivities. NWTF CEO George Thornton, read a letter from Palin, an avid hunter, angler and outdoorswoman, addressing the women who attended the event.

The women in attendance also enjoyed a surprise appearance and speech by the NWTF's newlynamed spokeswoman, Brenda Valentine. Known as the outdoor industry's "First Lady of Hunting<sup>TM</sup>," Valentine made her debut as the NWTF's official spokeswoman Friday, Sept. 26. Valentine's wide-ranging talents include that of an accomplished author, photographer, videographer and radio personality, and she is the first female inducted into the Legends of the Outdoors Hall of Fame.

Valentine makes regular appearances on the new "Bass Pro Shops' King of Bucks" program on Outdoor Channel, and is also a host of the "Bass Pro Shops' Real Hunting" show that airs weekly on the Versus Network. As spokeswoman, Valentine will make appearances on the NWTF's television shows and contribute to the NWTF's Women In The Outdoors magazine.

"I am honored and excited to have been invited to serve as the first official spokeswoman for the NWTF," said Valentine. "I have been a friend and supporter of the NWTF for many years and am now looking forward to a more active role in helping all staff and members to further enhance the future of the wild turkey and our hunting heritage."

In addition to hearing from Palin and Valentine, who have brought positive attention to the outdoor industry, participants were treated to speeches by the NWTF's second woman president, Peggy Anne Vallery and acclaimed author, photographer and speaker, Laurie Lee Dovey.

Participants also had opportunities to enjoy more than 30 hands-on classes including fly fishing, kayaking, camping, Dutch oven cooking, outdoor photography, archery, shotgunning, ATV safety, turkey calling and much more in a beginner-friendly, stress-free environment.

# **Harvest Management**

Preliminary spring 2008 harvest, calculated from report cards, was approximately 40,522 (38,568 first harvest + 1,954 second harvest, Table 1). Harvest from mentored youth will not be available until next year. The first harvest is 9% above the previous 3-year preliminary average (35,378). Even though spring harvests are down from the record 49,186 in year 2001, Pennsylvania hunters have consistently maintained spring harvests above 30,000 since 1995.

Spring 2008 turkey hunters purchased 8,795 special turkey licenses (7,585 in 2007, 8,041 in 2006). We mailed reminder letters to 1,000 randomly selected non-reporters, of which 92% did not harvest a second turkey. The estimated harvest was 1,954 (1,507 in 2007, 1,454 in 2006) with a success rate of 22 % (compared to 20% in 2007, 18% in 2006).




Figure 2. Fall and spring wild turkey harvests in Pennsylvania, 1975 – 2008. Spring 2008 data are preliminary.

The final spring 2007 harvest was 41,376 (36,373 first harvest + 1,507 second harvest + 3,496 mentored youth harvest, Table 1, Figure 2). The first harvest was 4% less than spring 2006 (37,843). From 2000-2003 we experienced record harvests of over 40,000 bearded birds.

The final fall 2007 harvest was 25,369, 4% higher than 2006 (24,482), but 6% lower than the previous 3-year average (26,918; Table 1, Figure 2). This trend of lower harvests is due to a combination of shorter seasons in almost half of the WMUs since 2004, average to below average spring reproduction, fewer fall turkey hunters, and abundant fall mast crops, which tend to disperse turkey flocks making them more difficult for hunters to locate.

There were 223,808 hunters for the spring 2007 season, which is slightly below the 10-year average of 232,014. Statewide hunter success was 16%, similar to the previous 10-year average. Spring hunter success has been as high as 21% (2001, along with the record harvest), and as low as 3% (1978). Total number of days hunted during spring 2007 for the first turkey (894,393) decreased 5% from 2007 (937,021) and 11% from the previous 10-year average (1,005,778).

During the 2007 youth season 5,911 juniors hunted harvesting 1,650 birds (28% success rate). 2007 was the second year mentored youth could participate in the spring turkey season. Of the estimated 58,883 total mentored youth for all mentor species, 52,032 days were spent pursuing wild turkey with 3,496 spring gobblers harvested, approximately 8.4% of the total spring harvest.

The number of fall turkey hunters has been decreasing, with only 162,323 fall hunters in 2007, 27% below the previous 10-year average (221,125) and the second consecutive year of lowest number of hunters since records have been kept (1978). Even though participation has been decreasing, statewide fall hunter success increased in 2007 to 16% (13% in 2006), and was 15% higher than the previous 3-year average. Hunter success has been as high as 21% (2001, a year with excellent recruitment), and as low as 4% (1979). Total number of days hunted during fall 2007 (522,911) was similar to 2006 (534,139), but decreased 21% from the previous 10-year average (752,802), and was the second consecutive year of least number of days hunted since records have been kept (1990). Fall turkey hunters and days hunted have been decreasing since the mid 1990s. Some of this decrease may be an accumulation of shorter fall season lengths during the past few years, as well as a shift in hunter preferences to other concurrent hunting seasons.

#### Wild Turkey Spring Harvest Rates and Annual Survival Rates Study

A manuscript on leg-band retention rate is in preparation. The results from these analyses (based on <570 days between release and recovery) indicate substantial band loss and are strong enough that a final year of data are not going to change the conclusion that butt-end band loss (of both standard aluminum and stainless steel butt-end bands) is unacceptable and loss rates are greater for adults.

#### **Eastern Mast Survey**

Three hard mast surveys were conducted in cooperation with the Eastern Region Oak Mast Survey being coordinated by the Virginia Department of Game and Inland Fisheries. The surveys represent 3 ecoregions within the state (Appalachian Plateau Glaciated High/Low Section, Appalachian Plateau Allegheny Mountain Section and Ridge and Valley Provinces). Bob Eriksen assists with this effort.

# Northeast Upland Gamebird Technical Committee Meeting

Mary Jo Casalena is the Pennsylvania representative for wild turkeys at this annual meeting, which now also covers ruffed grouse, American woodcock, Northern bobwhite quail and ring necked pheasant. State/provincial upland gamebird biologists from all northeast states and Canadian provinces, and technical representatives from the National Wild Turkey Federation, attended the 3-day meeting, which was held in Connecticut. The committee works on specific charges provided by the Northeast Wildlife Administers Association, specifically to identify and resolve population management issues associated with these various upland game bird species, as well as identify habitat needs and priorities to provide to the Northeast Upland Habitat Committee. The committee is also important for facilitating exchange of information and to establish coordination and collaboration on projects. The committee's list of priorities for turkey research to the NWTF 2009 Grant-in-Aid research funding included studying hen harvest/survival rates, which fits in well with the PGC's Turkey Management Plan. NWTF considers priority lists from all Turkey Technical Committees when finalizing the national priority list.

### **Regional Wild Turkey Population Model**

Poult production data were collected this year with the statewide WCO turkey summer sighting surveys. During the next few months these data, that are required for the model, will be summarized, analyzed and then used in the model.

# Joe Kurz Award Recipient

The Game Commission thanks the PA NWTF Board for selecting Scott Bills, PGC Land Manager for Dauphin and Lebanon Counties. We wish him luck, as his nomination will be included in the national selection during the 2009 NWTF Convention. Thank you also for your continued support for assisting with PGC travel expenses to this Convention. However, the Commonwealth is operating under an out-of-state travel freeze, which will probably affect Convention attendance by PGC staff.

We corrected hyperlinks to the Turkey FAQ (Frequently Asked Questions) and the turkey management plan and updated harvest maps for the agency website.

#### WMU 5A Wild Turkey Task Force

This task force, formed in 1997, is comprised of staff from PGC, DCNR-BOF, NWTF, PANWTF and Local NWTF Chapters NWTF, meeting once annually to review progress of the existing turkey management recommendations for WMU 5A and determine what work is needed to increase this turkey population and how it can be accomplished through this cooperative task force. This year's meeting will be October 7, 2008.

# PA Chapter NWTF Wild Turkey Management Report - August 21, 2008

#### Wild Turkey Management changes require PGC Staff and Commissioner overview.

- 1) Support revised PGC <u>Management Plan For Wild Turkeys In Pennsylvania</u>, 2006-2015, operational with 47 strategies documented, measuring strategies as outlined, and the plan fully funded for 10 years;
- 2) Northeast Wild Turkey Population Model implement in wild turkey management plan PA NWTF has \$15,000 invested in development; model data and modeling results are requirements for future wild turkey management decisions;
- 3) Recommendation to extend last day of spring gobbler season to May 31 --- Commissioner's approved Memorial Day, May 26, 2008 as last day of 2008 spring gobbler season under final rule making on April 18, 2007 Commissioner meeting; Commissioner's approved Memorial Day, May 25, 2009 as last day of 2009 spring gobbler season;
- 4) Recommendation for Mentored Youth Hunting to including fall turkey hunting season in regulation;
- 5) Recommendation to expanding youth spring gobbler season and regular spring gobbler season to all day hunting starting 2011, after 4 year gobbler leg band research project is completed in 2009 and project evaluation is completed by 2010;
- 6) Recommendation to expanding youth spring gobbler to more than one day;
- 7) Continue recommendations to reduce WMU fall season lengths as management plan setting fall season guidelines are determined; using management data based on current field data, harvest densities information, population densities and hunter densities, as charted measurements outlined in the wild turkey management plan; and to increase fall season lengths when management data supports regulation change;
- 8) Additional second spring gobbler regulation continue review and recommend additional changes if/as needed;
- 9) State-wide gobbler leg band research first year 2006 completed, second year 2007 completed, third year 2008 completed, fourth year for project Winter 2009; first three years of research project funding support from NWTF and PANWTF is \$145,870 from NWTF Grant In Aid and PA Chapter NWTF Hunting Heritage Super Fund for research project equipment and materials; PGC funded administrative, staff and transportation requirements, other agency project expenses; [on-going on schedule]

10) Four year state-wide gobbler leg band study will be completed in 2009 – final project results and recommendations will be compiled by 2010; submit next wild turkey research proposal in 2008/2009 and request funding for state-wide hen telemetry study for 4 years – 2010-2013. [telemetry is Wild Turkey Management Committee and PANWTF Board recommendation]

#### Legislation changes require Governor signature.

- 1) PGC hunting license increase legislation supporting need for PGC additional revenue, and supporting alternative funding option recommendations. Turkey Hunting License continue with our position statement, articles and news release supporting need for combined spring and fall turkey hunting license, support fully funded wild turkey management plan to complete yearly objectives and strategies;
- 2) Support Sunday hunting as regulated by PGC, required legislation to change Title 34 Game Law;
- 3) Do not support legislation [Title 34 Game Code] through legislative wording that changes PGC seasons and bag limits; seasons and bag limits are PGC Regulation [Title 58 Regulation Code].
  - Dale Butler was recognized by a State Senator for his positive leadership at the local level.

# **Legislative Committee – Don Heckman**

PA General Assembly 2007-2008 session days left: The House and Senate will both be in session October 6<sup>th</sup>, 7<sup>th</sup> and 8<sup>th</sup>. They will then be adjourning until after the November election. The Senate has stated that they will not hold any voting session days following the election. The House has stated that they will be returning for a 7 day *sine die* session in November, however it remains to be seen whether that will take place.

Legislative Committee – will be reviewed at October Board meeting, legislation being watched and letters/emails being written:

HR 642 – Deer Audit by 3<sup>rd</sup> party, audit being funded by General Assembly

HB 251 [HB 1862] – legalize hunting outside 150 yard perimeter around bait anywhere in commonwealth during any hunting season

HB 641 - Castle Doctrine - amends Title 18 providing for further increased property owner protection

<u>HB 747</u> – Elk license lottery; 5-21-07 House Final passage [Vote Y: 196 / N: 1); Senate amendment made to bill to remove PGC Deputy WCO's; legislation re-referred to Appropriations; Sen. Armstrong amendment being pulled; amendment to change proceeds to 20%-80%;

HB 779 - legalize Sunday Hunting through Game Law Title 34 [not by Regulation Title 54]

HB 863 – extend spring gobbler season to all day

<u>HB 1214</u> – PGC Commissioner term limit, management by social and other recreational values; notified legislation will not come out of Committee as being passed over

<u>HB 1676</u> – State Sales Tax revenue going to PGC and PFBC; 1/8 of 1%, with appx \$10 M going to PGC and \$5 M going to PFBC;

Rereferred to Appropriations Committee

<u>HB 1845</u> – Amend Titles 18 and 42, further provide tougher laws to penalize people who commit various gun related crimes, further protecting law-abiding gun owners; 4-07-08 House Final passage [Vote Y: 200 / N: 0); currently in Senate Appropriations Committee

<u>HB 1862</u> [HB 251] – legalize hunting over shelled or ear corn anywhere in Pennsylvania during any hunting season

HB 2205 - Wildlife poacher(s) fines and penalties increases

HB 2364 - Interstate Wildlife Violators Compact law - add Pennsylvania to list of states

<u>HB 2381</u> – PGC should be guided and support by verifiable data with equal regard for social, economic, and recreational impacts; No longer permit current and former employees or DWCO to serve on Board of Commissioners; Rereferred to Appropriations Committee

HB 2525 – Amends dog law, including kennels and sporting dogs; on Version 3 in July. 9-16-08 House Final Passage (Vote Y: 187 / N: 17)

Over 50 amendments voted on between Committee and House on this legislation, only a handful was passed.

HB 2575 – Amends Title 34 (Game) providing for deterrent fences for deer, bear, & elk & the payment of claims for damages by certain elk; imposing duties on Dept. of Agriculture; establishment of the Elk Damage Fund. 9-15-08 House Final Passage (Vote Y: 199/ N: 1)

HB 2653 - bow definition change, legalize crossbow for all hunting seasons

SB 151- HB 1543 - legislation to ban pigeon shooting

<u>SB 740</u> -- Spring Creek Canyon land title to Penn State University and Brenner Township rather than PGC for game lands:

5-08-07 Senate Final Passage (Vote Y: 48/ N: 0); 6-18-08 House Final Passage with amendments (Vote Y: 185/ N: 13);

Referred to Senate Rules Committee; notified legislation will not come out of committee as being passed over

<u>SB 1527</u> – Senate Legislative bill to increase hunting license back tag and antlerless deer tags 3 times over next 7 years
