

Fiscal Year reports are attached. 75% through fiscal year and we are at 89% income and 71% expenses.







Final 2011-2012 Wild Turkey Seasons

During the April PGC Board of Commissioners meeting, the Board gave final approval to the following fall 2011 and spring 2012 turkey seasons.

The restructured fall season dates for 2011 are as follows:

WMUs 1A, 1B and 2A (Shotgun/archery only): Oct. 29-Nov. 12 and Nov. 24-26;

WMU 2B (Shotgun/archery only): Oct. 29-Nov. 18 and Nov. 24-26;

WMUs 2C, 2D, 2E, 4A, 4B and 4D: Oct. 29-Nov. 12 and Nov. 24-26;

WMUs 2F, 2G, 3A, 3B, 3C, 4C and 4E: Oct. 29-Nov. 18 and Nov. 24-26;

WMU 5A: Nov. 1-3;

WMUs 5B, 5C and 5D: Closed to fall turkey hunting.

Spring 2012 junior season, statewide: April 21. Hunting hours close at noon.

Spring 2012 season, statewide: April 28-May 31. Hunting hours close at noon, April 28 – May 12. Hunting hours close one-half hour after sunset, May 14- 31.

Harvest Management

Although our data resources division is still entering report cards into the database for the spring 2011 season, as of 28 May, with two full days remaining in the season, we received 10% less harvest report cards than by the end of the 2010 season, but 16% more than the end of the 2009. We continue to receive report cards 15 days after the close of the season (June 15), at which time we make our final count. Beginning this year hunters also were asked to report time of kill to assess the percent harvest occurring after noon.

Special turkey licenses sold for the 2011 spring season was 15,159, a 12% increase from 2010 and a 56% increase from the previous average since the special license was introduced in 2006. The increases during the last two years most likely are due to the computerized Point-Of-Sale Licensing System allowing this license sale from July 1 until the spring season opens. Prior to POS, license sales were limited to January 1 – April 1.


Wild Turkey Hen Harvest Rates and Annual Survival Rates Study

A turkey hunter survey was mailed to 10,000 general license holders after the fall 2010 season to determine hunter attitudes, satisfaction and daily participation with the new season structure. In summary, it appears, at least with this initial survey year, we did not recruit new turkey hunters, and did not reactivate former fall turkey hunters. But we did provide existing turkey hunters additional recreation opportunities with the new season segment during the Thanksgiving holiday. The majority of participants were satisfied with their 2010 fall turkey hunting experience. Available time, higher turkey populations and places to hunt are more important factors influencing fall turkey hunting participation than season structure. A PowerPoint presentation is provided separately showing more detailed results.

The turkey biologist worked with the PGC Regions and PCFWRU at Penn State regarding data management and locating transmitters from mortalities. As expected, once hens dispersed from winter flocks, mortalities of transmittered hens began, mainly predation. Of the 119 total hens transmittered since January 2010, 34 transmitters are active as of 2 June (18 of 61 in Study Area 1; 16 of 58 in Study Area 2).

Outcome of the other 85 transmittered are: 7 stopped functioning or were destroyed; 7 fell off due to equipment failure; 1 hen slipped out of transmitter harness; 1 censored (died within 1 week of trapping); 2 died from researcher error; 3 died of natural infection/disease; 3 legally





harvested; 3 illegally harvested; 20 general predation; 12 mammalian predation; 9 avian predation; and 17 unknown cause.

As of 26 May, hunters reported harvesting 3 bearded hens that were legbanded (\$100 reward for reporting) as part of the study (2 in SA1, 1 in SA2). Because bearded hens are legal to harvest during the spring season, we legband bearded hens at the proportion they are incidentally trapped; we do not seek out bearded hens for trapping. Three additional female reward bands were reported: 2 roadkilled and 1 found killed by a predator while it was incubating a nest. Legband reports of male turkeys harvested to date are 44 (non-reward bands); 26 leg-banded between 2006–2009 during the gobbler harvest rate study and 18 leg-banded between 2010-2011 during the hen harvest rate study. One gobbler banded during the gobbler study was 5 years old (harvested in Centre Co)! So far during the all-day portion of the spring season 87% of the 15 reported legbanded gobblers were harvested prior to noon.

One problem we have encountered is the transmitter harness design is failing after approximately 15 months on some birds, such that some transmitters are falling off live hens. We are working with the transmitter manufacturer to rectify the problem with all transmitters we have retrieved to date prior to the next turkey trapping season that begins mid-August.

Rocket charges are to be delivered for the upcoming late summer turkey trapping season when we will leg band an additional 150 hens (75 per Study Area), focusing on brood flocks to obtain a sample of leg banded juvenile hens. Transmitters recovered from mortalities will be redeployed after they are redesigned.

Wild Turkey Management Plan

The annual review of the wild turkey management plan strategies is underway in preparation for discussion during the annual PGC/PANWTF Cooperative meeting (June 8, 2011). Each PGC Bureau is reviewing management plan strategies they are responsible for to show outputs and outcomes, if the timeframe for accomplishments is being maintained, and identifying potential problems with implementation.

Hunting Related Shooting Incidents (HRSIs)

Preliminary information to date shows 5 HRSIs from this spring's turkey season, one unfortunately being fatal. Three are 2-party, failure to identify target incidents (NW Region); one self-inflicted from the NE Region (Susquehanna County); one self inflicted, fatal from the SW Region (Westmoreland Co). The victim shot himself in the chest with a 12 ga. as he was descending from a tree-stand. Please note this is a preliminary report, may not include all incidents and final results may change as investigations proceed. We will provide an update during the next quarterly meeting.

Information and Education

In cooperation with the Bureau of I&E MJ Casalena recorded 3 additional Radio PA segments regarding the spring turkey season, prepared the spring turkey hunting season forecast news release, provided hunting forecast for several outdoor writers and individual turkey hunters,



responded to more than 25 phone and email inquiries regarding timing of the spring season, turkey hunting and biology/population/habitat management.

NWTF Convention

The two PGC award recipients and Turkey Technical Committee member, Mary Jo Casalena, enjoyed the Convention and associated meetings. The PGC is very appreciative of the financial assistance from PANWTF to defray part of the Technical Committee member's travel expenses.

Michaux State Forest Summer Sighting Surveys

With the re-opening of fall turkey season in WMU 5A, we are continuing monitoring the turkey population in the Michaux State Forest, where the majority of the turkey population and harvest exists. Thanks to a well-established cooperative effort among the PGC, DCNR Bureau of Forestry (BOF), and volunteers from local NWTF chapters, the 14th year of weekly Summer Sighting Surveys on the Michaux State Forest are underway to provide an additional index to turkey population trends besides our harvest and hunting success trend data for WMU 5A. This is the area of the turkey radio-telemetry study where we investigated the causes of the suppressed wild turkey population and closed the fall season from 2003 - 2009 to aid in population recovery. Additionally, since 2002, BOF staff record each day, turkeys they see and miles driven, as an additional index of the turkey population.

Wild Turkey Management – J. Panaro/D. Heckman:

PA Chapter NWTF Wild Turkey Management Committee Report June 5, 2011 PANWTF June Board Meeting Submitted by Don Heckman, WTM Committee

Wild Turkey Management changes requiring PGC Staff and Commissioner overview.

- 1) Support PGC Management Plan For Wild Turkeys In Pennsylvania, 2006-2015, goal, 8 objectives 47 strategies, with measurement timeline outlined, plans needs to be fully funded over the 10 years; several management plan strategies are not being fully funded or followed.
- 2) Northeast Wild Turkey Population Model implement in wild turkey management plan PA NWTF has \$15,000 invested in development; model data and modeling results are requirements for future wild turkey management decisions; Mary Jo updating model for implementation.
- 3) Recommendation to extend last day of spring gobbler season to May 31, permanently ---

FINAL COMMISSIONER APPROVAL - BOC Meeting April 20, 2010.

- 4) Recommendation for Mentored Youth Hunting to including fall turkey hunting season in regulation starting in 2011. PANWTF needs to continue to support "tag sharing" with Mentored Youth Hunters and then work with PGC to get their support for fall turkey hunting with fall antlerless hunting when the legislation is signed into law. SB 274 legislation passed by Senate G&F Committee gives PA Game Commission regulator authority for adding additional wildlife species to fall hunting seasons and bag limits.
- 5) Recommendation to expand youth spring gobbler season and regular spring gobbler season to all day hunting after 4 year gobbler leg band research project is completed in 2009, project evaluation will be completed in 2010, and recommendations will be documented. At April 20, 2010 PGC Commissioner meeting they voted 8-0 to expand spring gobbler season for last two weeks of spring season up to May 31 to all day hunting starting Spring 2011. All day youth spring gobbler season will be reviewed for additional hunting opportunity.
- 6) Recommendation to expand youth spring gobbler to more than one day.

to PGC Executive Staff, Commissioner's, PA Chapter NWTF?

- 7) Continue recommendations to reduce or increase WMU fall season lengths as management plan setting fall season guidelines are determined; using management data based on current field data and indices, harvest densities, population densities, and hunter densities, as charted measurements outlined in the wild turkey management plan; when management data supports regulation change. Fall turkey hunting regulations for season start and end date changes were adopted by PGC BOC at April 20, 2010 Meeting. PANWTF and member articles have been distributed documenting our disapproval of these approved fall turkey hunting season regulations fro 2010. Feb. 1, 2011 under Proposed Rule making, Commissioner's move tentative fall turkey hunting season start date back to last Saturday of October. Saturday October 29, 2011 will be first day of fall turkey hunting season, while WMU's will be back tp 1, 2, 3 weeks, plus 3 days for WMU 5A, or closed fall turkey hunting season in WMU 5B, 5C, 5D. Thanksgiving Day, Friday, and Saturday fall turkey hunting for 2011 is still in seasons and bag limits criteria as adopted by Commissioners. 2011, 4th Saturday, October 22 continues to be closed for fall turkey hunting and continues to be opening day Bear Season Start date. April 19th PGC Board of Commissioners adopted these season and bag limit dates under Final Rule Making for 2011. 8) PGC Gobbler Leg Band Research Study (2006-2009) has been completed. Study results have been documented by Dr. Duane Diefenbach and Mary Jo Casalena, and handed out to PA Chapter NWTF Board. What will be the PGC recommendations coming out of this research study and how will they be presented
- 9) PGC submitted Fall Hen Harvest Rates Study to NWTF Technical Committee requesting funding for state-wide hen research/telemetry study for 4 years 2010-2013. Bob Boyd resubmitted and presented NWTF Grant-In-Aid proposal for 2011-2013. NWTF approved funding for 2011 trapping sessions. Mary Jo, Ian, or John Dunn and Bob Eriksen can update Board on final decision and payment schedule.

10) Wild Turkey Biologists Spring Options white paper has been finalized March 2010 for PGC Executive Staff and Commissioner's review. Number of Spring Options changes have been adopted under final rule making by Commissioner's like expanding spring gobbler season to all day hunting for last 2 weeks up to May 31 for spring season starting in 2011 No further reports back from Commissioner's or Executive Staff on other white paper suggestions or changes.

11) June 8, 2011, PGC Staff meeting with PA Chapter NWTF representatives in Harrisburg Headquarters building was held. Need to review action items and meeting minutes from June 2010 meeting for updates and changes.

Legislation changes that require Governor signature.

- 1) Spring Turkey Hunting License proposed by PA Chapter NWTF Board of Directors. Support statement and benefits talking points will need to be distributed to several key Legislator's, PGC Executive Staff, PGC Commissioner's, Local Chapter Presidents, NWTF Members, and turkey hunters if this moves forward.
- 2) PGC hunting license increase legislation Legislation has been submitted, SB 740, in this legislative session, 2011-2012.
- 3) Support Sunday hunting as regulated by PGC, required legislation to change Title 34 Game Code. No Legislative was taken on legislative bill in 2009-2010 legislative session. Legislative bill will be introduced in 2011-2012 legislative session.
- 4) Do not support legislation [Title 34 Game Code] through legislative wording that changes PGC hunting seasons, bag limits, and shooting hours. PGC hunting seasons, bag limits, and shooting hours are changed by Board of Commissioners through PGC Regulation [Title 58 Code].

Other Committee actions requiring PA Chapter NWTF Board participation and overview. PANWTF Spring Turkey Hunter Cooperative Program for Spring 2011 will be scheduled.

Other Committee actions requiring PGC Staff and Commissioner participation and overview.

- 1) Turkey hunting safety and ethics New PGC Turkey Hunting Curriculum Course on schedule for Spring 2011 kick-off. Other PANWTF / PGC wild turkey hunter safety material NWTF Turkey Hunter Safety DVD provided to PGC HTE classes; helping PGC reach out to 300,000+- turkey hunters with additional turkey hunter safety and ethics information and material; PA Edition NWTF Turkey Hunting Success and Safety brochure; NWTF Turkey Hunter Safety Task Force material; New updated PANWTF Turkey Hunting Safety posters.
- 2) Annually review of meeting minutes from PGC Executive Staff and PA NWTF June meeting as provided by PGC Wild Turkey Biologist Mary Jo Casalena. Final June 2010 meeting minutes were forwarded to PGC Staff and PANWTF Board. Important wild turkey management criteria and decision making changes have been accomplished since these joint partnership yearly meetings started back in the mid 1980's. Continue request for PGC wild turkey biologist to update PA Chapter Board at the January and June board meetings on status of Objectives and Strategies as outlined in the PGC Management Plan For Wild Turkeys In Pennsylvania.
- 3) NWTF wild turkey management outreach programs Wild Turkey Woodlands, Habitat Management, Safety Education, Land Acquisition, Conservation Seed programs, Project HELP, Operation Appleseed, Operation Oak, other budgeted NWTF outreach programs and HHSF Super Fund expenditures, support funding for NWTF's Pennsylvania Comprehensive Wild Turkey Management Plan, continue distributing PANWTF news releases and articles in Turkey Talk, Tell The Story Pass It On.
